MEMORANDUM OF UNDERSTANDING FOR COOPERATION

THE FIRST PARTY: Fundação Minerva - Cultura - Ensino e Investigação Científica, founding entity of the Universidade Lusíada, collective entity n. 501 679 260, with headquarters at Rua da Junqueira, 188-198, 1349-001 Lisbon, for the present purposes represented by the Vice-Presidents of the Administration Board, Prof. Dr. João José de Pires Duarte Redondo, Prof. Dr. Ricardo Luís Leite Pinto, and by the Rector of the Universidade Lusíada de Lisboa, Prof. Doutor Afonso Filipe Pereira d'Oliveira Martins.

and

THE SECOND PARTY: Center for Strategic Research of the Ministry of Foreign Affairs of the Republic of Turkey, with headquarters at Dr. Sadık Ahmet Cad., n. 8, Balgat / Ankara 06100 Turkey, for the present purposes represented by the Chairman, Prof. Dr. Ali Resul Usul.

Whereas the Fundação Minerva - Cultura - Ensino e Investigação Científica is an institution headquartered in Lisbon, the public interest of which is recognized in Decree-Law n. 117/2003, of 14 June, and which has as its statutory goal the pursuit of cultural and scientific ends, including those of an educational nature;

and whereas the Fundação Minerva - Cultura - Ensino e Investigação Científica, for those statutory ends is the founding entity of establishments of private higher education, hereinafter "Universidades Lusíada";

and whereas the Universidades Lusíada have as their mission the production and diffusion of knowledge and cultural, artistic, technological, and scientific training of its students at the international scale, as well as their ethical and civic training;

and whereas the Center for Strategic Research of the Ministry of Foreign Affairs of the Republic of Turkey, hereinafter "SAM", with its commitment to contribution to the body of knowledge and constructive debate particularly in Turkish Foreign Policy, SAM will continue to serve as an indispensable think-tank and research center given its role promoting interaction and mutual benefits among the MFA, NGOs, other think-tanks and the broader scientific community and hence strengthen the human and intellectual capital of Turkey.

The present instrument (hereinafter "Memorandum of Understanding") is entered into by mutual agreement of the parties specified above, and duly signed by the legal representatives of said parties, who agree to the following clauses and conditions stipulated:

CLAUSE I - GOALS

The goals of the present Cooperation Agreement between the two parties specified above are the following:

- Both institutions will maintain an active exchange of information about their activities;
- Both institutions will exchange information related to activities of common interest, taking into consideration possible joint participation in meetings of bilateral, regional and international character;
- Both institutions will facilitate the exchange of their monographs, research papers, periodicals, and other pertinent printed and electronically published material on topics relevant to the issues of scientific and mutual interest;
- Both institutions will consult on the possibilities of organizing conferences, round-tables, symposia, panels and discussions, brain-storming sessions and seminars that could be held alternately in Turkey and Portugal such activities could also be organized with the participation of third parties;
- Both institutions will facilitate the exchange of conference speakers, experts and researchers.

CLAUSE II - COORDINATION

The coordination of the projects covered by this agreement, will be exercised by both parties, as follows:

- Center for Strategic Research of the Ministry of Foreign Affairs of the Republic of Turkey.

CLAUSE III - RESERVATION OF RIGHTS

Inventions, intellectual property rights, author's rights, and the benefits pertaining to work developed as a result of the present Memorandum of Understanding and respective Added Terms shall be protected and reserved by previous accord, in writing, between the parties specified above, according to current law.

CLAUSE IV - CONFIDENTIALITY

Both parties to the present Memorandum of Understanding agree not to divulge, in any form, the information of scientific and/or technical and/or any other nature, belonging to or reserved to the other party, whenever such divulgation is not authorized or whenever the information in question is not in the public domain.

For the purposes of the present Memorandum of Understanding and respective Added Terms, the term "restricted information" will signify any and all information pertaining to the development of the projects.

Any finding emerging from the pursuit of project(s) that are undertaken under the auspices of the present Cooperation Agreement may be published only upon the express and written authority of both parties, and if and/or when published, acknowledgement of the present Memorandum of Understanding will be included therein.

Both parties committed themselves and their partners in any and all contracts they may have to not divulge the findings of projects and/or their development without the previous and written permission of the other signatory party of the present Memorandum of Understanding.

CLAUSE V - INTERPRETATION

Any doubts arising from the application of the clauses of the present Memorandum of Understanding will be clarified and interpreted by joint accord of both parties in such a way that said interpretation most favours the pursuit of the ends expressed herein.

CLAUSE VI - PERIOD OF EFFECTIVENESS

The present Memorandum of Understanding will remain in effect for a period of 3 years counting from the date of its signing, and will be renewed for the same periods, unless there is explicit notification to the contrary from one of the parties to the other at least 90 days before the date of expiry.



CLAUSE VII - TERMINATION / NULLIFICATION OF AGREEMENT

The present Memorandum of Understanding may be terminated by either of the parties at any time by means of notification of such intent with prior notice of no less than six months, or the Agreement may be nullified in the event of failure to comply with any of the clauses or conditions stipulated herein.

CLAUSE VIII - PROMULGATION

It will be the responsibility of each of the parties individually to promulgate notice of the present Memorandum of Understanding by means of the communication channels deemed appropriate by said parties individually.

In full agreement with the clauses and conditions prescribed herein, the parties affix their signatures to the present Memorandum of Understanding below, on duplicate and equally binding instruments, one copy to be retained by each of the parties.

Signed in Ankara on 16 day of the March of the year 2015, in two original copies in English.
